I. OBJECTIVE AND METHODOLOGY

Objective

This is the 13th issue of the “Top 200 Myanmar Companies Report 2020”, prepared for the use of companies or individuals, national or international, who are interested to contact or to collaborate in doing business with top local companies listed in this report, for objectives such as but not limited to—expanding their business, exploring new business opportunities or for utilizing it for their research purpose, etc.

Methodology

How did MSR choose the top companies for “Top 200 Myanmar Companies 2020”?

- First of all, a list of local companies actively doing business in various sectors are acquired from the MSR databank.
- Secondly, to collect necessary information, desk research is conducted with the publications (government gazette, newspaper, journals, etc.) in Myanmar or through the Internet search.
- Thirdly, export and import statistical data, acquired from the Customs Department under the Ministry of Planning and Finance, are entered in each profile of the companies.
- Fourthly, the data already entered are reviewed and the most relevant companies which should be listed as Top 200 Local Companies (according to their reputation, size and engagement) in the sectors are selected.
- Finally, each of the companies listed is contacted by phone for validation of the data and also for confirmation that they are still active.
- The above procedures rotate every year. For compiling each issue, the previous year’s list of companies is updated as first priority by contacting each of them with the reviewing of the up-to-date data acquired through desk research. If a company listed previous year is found no longer active or defunct, it is removed from the list and replaced with a new one.

As almost all the business entities in Myanmar are private limited companies, they do not tend to reveal their financial conditions. In the Myanmar context, it is difficult for us to list them according to their financial status and assets. Instead, we consider the following points as our criteria in selecting the top companies:

- (1) Companies/groups of companies which are already prominent in Myanmar
- (2) Companies which are taking part in largest projects, especially in national-level projects.
- (3) Companies which are engaged in wide business activities as publicized by the print media, for example, working in joint-venture or partnership with FDI companies.

As we have compiled this report with the extensive knowledge and experiences in research area, accumulated over the last 22 years since 1995, the year of MSR’s inception, we believe this report will be of great help to you in consideration of growing your business.
